

**RESOLUTION**

**ADOPTED: JUNE 10, 2019**

**WHEREAS**, the Township solicited sealed bids for the provision and application of Rubberized Asphalt Chip Seal, Bid Number 2019-B01, on an as needed and ordered basis with no guaranteed minimum quantity ("Project"); and

**WHEREAS**, sealed bids for the Project were received and opened by the Township Qualified Purchasing Agent on May 29, 2019; and

**WHEREAS**, only one bid for the Project was submitted which bid was submitted by All States Asphalt set forth as follows:



**WHEREAS**, the Director of Public Works and Qualified Purchasing Agent recommend the award of a one year contract for the Project to All States Asphalt in accordance with the bid submitted in an amount not to exceed \$300,000 for 2019 with a Township option to renew for an additional one year term.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Branchburg, County of Somerset, State of New Jersey, that: (1) a one year contract for the Project is hereby awarded to All States Asphalt in accordance with the bid submitted in an amount not to exceed \$300,000.00 for 2019 with a Township option to renew for an additional one year term; (2) the Qualified Purchasing Agent is hereby authorized to issue Purchase Orders as needed for each calendar year of the contract in accordance with N.J.A.C. 5:30-5.5(b)2 subject to the availability and appropriation of funds.
