

RESOLUTION

ADOPTED: APRIL 26, 2021

WHEREAS, sealed bids were received on April 20, 2021 by the Township Qualified Purchasing Agent for the provision of Lifeguards at Branchburg’s Silver Saddle Community Pool for the 2021 summer season, May 29, 2021 - September 6, 2021 (“Project”); and

WHEREAS, one bid was received from USA Management, LLC and reviewed by the Township Qualified Purchasing Agent who deemed the bid complete, responsive and responsible; and

WHEREAS, the Township Director of Recreation has also reviewed the bid submitted by USA Management, LLC and has determined that it meets the requirements of the Bid Document and Scope of Work; and

WHEREAS, the Township Qualified Purchasing Agent and the Township Director of Recreation recommend that a contract be awarded to USA Management LLC for the provision of Lifeguards at Branchburg’s Silver Saddle Community Pool for the 2021 summer season, May 29, 2021 - September 6, 2021 (“Project”).

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Branchburg, County of Somerset, State of New Jersey, that: (1) a contract for the Project in the amount of \$63,510.00 be awarded to by USA Management, LLC for the provision of Lifeguards at Branchburg’s Silver Saddle Community Pool for the 2021 summer season, May 29, 2021 - September 6, 2021 (“Project”); and (2) the contract shall include additional Lifeguard hours as authorized by the Director of Recreation at an hourly rate of \$19.50 for a Lifeguard Manager/Supervisor and an hourly rate of \$16.85 for Lifeguard Staff; and 3) the Mayor and Township Clerk are hereby authorized to execute the contract with USA Management, LLC, 1595 Peachtree Parkway, STE 204-344, Cumming, GA 30040; and (3) the Qualified Purchasing Agent is hereby authorized to issue Purchase Orders as needed for the term of the contract in accordance with N.J.A.C. 5:30-5.5(b)2 subject to the availability and appropriation of funds.
