## **A VALID PERMIT IS REQUIRED**

*Resident's Vehicle Registration is Required to Obtain a Permit.*

Permits can be purchased at the Township Clerks' Office located at the Municipal Building, 1077 US Highway 202 North, Mondays to Fridays between the hours of 9:00 am and 4:00 pm.

## Permit Fee: \$25.00 (cash or check)

\$ - Cars, Station Wagons, Minivans, SUV'S = **5 Trips**

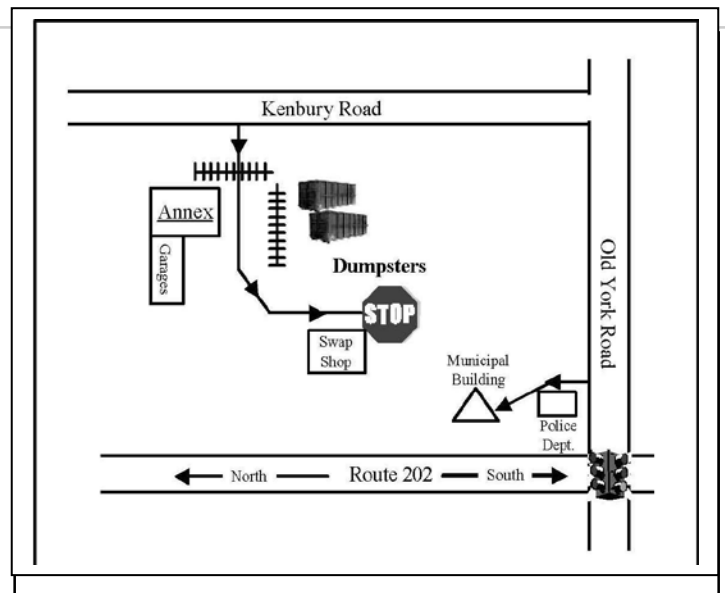
\$ - Pickup Trucks, Vans, Utility Trailers (max 8 feet long) = **2 Trips**

Permits are **NON TRANSFERABLE, NON-REFUNDABLE and** are only valid for 2 years from date issued.



The Dumpsters are located by the Annex/Public Works Facility at 34 Kenbury Road.

## How to Obtain a Dumpster Permit

- Permits can be obtained at the Township Clerks' Office Monday thru Friday, 9:00 am to 4:00 pm.
- To obtain a permit the Registration of your vehicle must be presented and must bear Branchburg Residency. No one will be allowed to use the dumpster without a valid permit.
- Permits will bear the resident's name, address, phone number and vehicle license plate number.
- For those residents who do not have the means of getting to the Dumpster and must borrow a vehicle in order to dispose of large items, a SPECIAL PASS will be given for a valid Permit.
- **To obtain a Special Pass** you must come into the Township Clerks Office **before using the dumpster**. You must have the original permit as well as the license plate number and type of vehicle you will be borrowing.
- **NO COMMERCIALY PLATED VEHICLE WILL BE ISSUED A DUMPSTER PERMIT.**

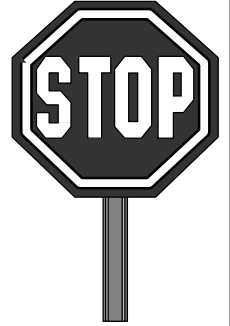
## General Rules

- **NO ONE IS ALLOWED TO USE THE DUMPSTER WITHOUT A VALID PERMIT.**
- **One Visit per day.**
- **DO NOT tear off coupons**, this must be done by the attendants. Attendant will remove coupon(s) and show you which dumpster to use.
- **Attendants will remove two (2) coupons** for anyone who uses a larger vehicle different than what is stated on the original permit OR removes/puts seats down.
- Pickup trucks can be filled **no higher** than the side of the bed.
- Utility trailers (NO LONGER THAN 8 FEET LONG) can be filled **no higher** than the side of the trailer.
- **NO Contractor/Commercial vehicles will be allowed.**
- *Residents are responsible for unloading and placing materials into the dumpsters.*

**Attendants have the authority to deny any individual the use of the dumpsters when they do not meet the requirements.**

## UNACCEPTABLE ITEMS

- Refrigerators, Air Conditioners and Dehumidifiers are not accepted due to strict Freon laws
- Kitchen Garbage
- Vehicle parts, including motor oils
- Paints, any type (see page 4.)
- Construction Material consisting of the following, but not limited to: CONCRETE, BRICKS, STONE, ROCKS, CEMENT, DIRT
- PRESSURE TREATED WOOD: Railroad Ties, Stumps, Logs.

- Items that can be recycled: Glass, Aluminum, Cardboard, Paper, Bi-metal cans, Compact Fluorescent Lights.
- Hazardous Waste: propane tanks, pesticides, auto products, fire extinguishers, etc. For more information on hazardous waste contact Somerset County at (908) 231-7031.



## Acceptable Items for Disposal at the Trash Dumpsters

- Household appliances. (Examples: Microwaves, washers, dryers)
- Furniture, toys
- Household construction material, no more than 1 cubic yard
- Tires, no more than 4 without rims



## Acceptable Items for Disposal at the Vegetative Waste Dumpster

- Grass **MUST** be placed in a special dumpster. (Plastic bags **CANNOT** be placed in the dumpster)
- Tree limbs must be no longer than 6-foot lengths.





## **Swap Shop** (permit is now required)

There is a 'swap shop' located on our dumpster site which will house useable and fixable items that you may no longer need or want.

Just tell the attendant that you have items to donate to the 'swap shop' and they will direct you to where the items should go.

**ITEMS THAT WILL NOT BE ACCEPTED** at the 'swap shop' are as follows:  
**ELECTRONIC ITEMS, TIRES, SINKS, TOILETS, PROPANE TANKS, MATTRESSES, BOX SPRINGS AND BATTERIES** and any other items that the attendant deems unacceptable.

### **All Recycling is done by Somerset County Recycling\*\*.**

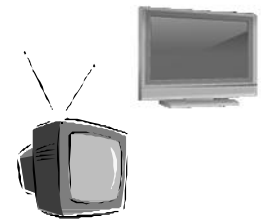
